At Array Solders, we are committed to safeguarding your privacy. This Privacy Policy outlines the limited circumstances under which we may collect, use, and disclose information. Please note that Array Solders typically conducts business with companies and other organizations, not individuals, and therefore does not collect personal information in the usual course of business.

1. Scope of Information Collection

Array Solders primarily engages in business-to-business (B2B) transactions, and as such, we do not typically collect personal information. The nature of our business – manufacturing and supplying solder preforms – means we generally interact with companies and their representatives rather than individual consumers.

However, in rare cases where personal information may be collected (such as when communicating with individual representatives of our corporate customers), the following details apply:

Personal Information (If Applicable):

Name, business email address, business phone number, and job title of company representatives. Any other business-related contact information voluntarily provided.

Non-Personal Information:

Information about your device, browser, and IP address when you access our website.

Data related to your usage patterns on our website, gathered through cookies or similar technologies.

2. How We Use Collected Information

In the rare instances where personal information is collected, we will use it solely for:

Communicating with representatives of corporate customers, including responding to inquiries and processing orders.

Facilitating the delivery of our products and services to companies and organizations. Complying with legal obligations, resolving disputes, or enforcing agreements. We will not use any collected information for personal or consumer marketing purposes.

3. Sharing Your Information

As we typically do not collect personal information, the sharing of personal data is highly limited. However, if such information is collected, we may share it under the following circumstances:

Service Providers: We may share business contact information with service providers who help facilitate the operations of our business (e.g., logistics providers or IT support).

Legal Requirements: We may disclose information if required by law or in response to legal processes to protect our rights or comply with regulatory obligations.

Business Transfers: In the event of a merger, acquisition, or sale of assets, business contact information may be transferred to the acquiring entity.



4. Data Security

Array Solders is committed to maintaining appropriate security measures to protect any limited information that may be collected, including the use of industry-standard technologies and safeguards. However, as no system can be entirely secure, we cannot guarantee absolute protection.

5. No Collection of Consumer Personal Data

As previously stated, Array Solders does not typically collect personal information from individuals, as we primarily engage with companies and organizations. We do not engage in business with individual consumers, nor do we market to them. Any personal data incidentally collected from individuals in their business capacities is treated as strictly business-related and subject to our business processes.

6. Cookies and Website Tracking

We use cookies and similar technologies to gather data about your interactions with our website, such as pages visited, time spent, and device information. This data is non-personal and is used solely for improving the functionality and performance of our website.
